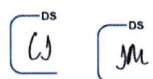

Policy Statement

Background Information

This action will transfer a total of \$350,000 between projects, within the ENGINEERING SERVICES Department, within the 2020 SALES TAX FUND [FUND 409].

This action will transfer available funds of \$350,000 from the Citywide Public Facilities Rehabilitation & Repair Project, to the Greenwood Cultural Center Rehabilitation project, in order to advance fund design work for the Greenwood Cultural Center.

The interim repairs and conceptual study for the Greenwood Center is now completed and the design team is ready to move into the design phase of the project. The transferred funding is needed to allow execution of the design agreement. This transferred amount, plus the existing balance in 2234B00000 will be used for design services to produce the construction documents for the building rehabilitation.

This transfer will not interrupt progress on the City Citywide Public Facilities Rehabilitation & Repair Project. In FY24, the \$350,000 will be restored to the Citywide Project. All projects within the 2020 Sales Tax Program will continue as originally outlined in ordinance.

AN ORDINANCE AMENDING THE FISCAL YEAR 2022-23 BUDGET OF THE CITY OF TULSA, OKLAHOMA, BE AND IT IS HEREBY AMENDED TO TRANSFER UNENCUMBERED AND UNEXPENDED APPROPRIATION BALANCES OF THREE HUNDRED FIFTY THOUSAND DOLLARS AND ZERO CENTS (\$350,000.00) BETWEEN PROJECTS, WITHIN THE 2020 SALES TAX FUND (FUND 409), AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the Fiscal Year 2022-23 Budget of the City of Tulsa, Oklahoma, be and it is hereby amended to transfer unencumbered and unexpended appropriation balances of Three Hundred Fifty Thousand Dollars and Zero Cents (\$350,000.00) between Projects, within the 2020 Sales Tax Fund (FUND 409), as follows:
