AN ORDINANCE AMENDING THE FISCAL YEAR 2023-24 BUDGET OF THE CITY OF TULSA, OKLAHOMA, TO MAKE SUPPLEMENTAL APPROPRIATIONS OF TWO HUNDRED THOUSAND DOLLARS (\$200,000.00) RECOGNIZED FROM UNAPPROPRIATED FUND BALANCE WITHIN THE PD EQUITABLE SHARING JUSTICE SUBFUND (SUBFUND NO. 2400) AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the Fiscal Year 2023-24 Budget of the City of Tulsa, Oklahoma, be and it is hereby amended to make supplemental appropriations of Two Hundred Thousand Dollars (\$200,000.00) recognized from unappropriated fund balance within the PD Equitable Sharing Justice Subfund (Subfund No. 2400), as follows:
