AN ORDINANCE ADOPTING THE THIRTY-SECOND SUPPLEMENT TO THE SEVENTH REVISION OF THE TULSA REVISED ORDINANCES, CODIFYING ORDINANCES ENACTED BETWEEN JANUARY 1, 2023, AND APRIL 30, 2023; PROVIDING CERTAIN EXCEPTIONS FOR ORDINANCES EXCLUDED; PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES; PROTECTING PREEXISTING RIGHTS; PROVIDING FOR COPIES TO BE DEPOSITED WITH THE CITY CLERK; PROVIDING FOR DISTRIBUTION OF COPIES TO CITY DEPARTMENTS AND OTHERS; PROVIDING FOR THE SALE OF COPIES; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY OF TULSA:

SECTION 1. ADOPTION OF SUPPLEMENT NUMBER 31. This ordinance shall adopt the Thirty-second Supplement ("Supplement No. 32") dated May 1, 2023, to the Seventh Edition of the Tulsa Revised Ordinances.

SECTION 2. EXCEPTIONS. Ordinance No. 25041, enacted June 4, 2023, and all ordinances enacted subsequent thereto, are not included in Supplement No. 32 to the Tulsa Revised Ordinances; and it is hereby provided that all such subsequently enacted ordinances, and all temporary and special ordinances containing subject matters not subject to codification, shall continue in full force and effect from and after the date hereof until hereafter repealed.

SECTION 3. SAVING CLAUSE. Neither the repeal of any ordinances nor any of the provisions herein contained shall be deemed or construed to impair, modify, alter or affect any rights, rights of action or causes of action, whether now pending in any court or not, which are now existing or which may arise or come into existence, before the date when Supplement No. 32, above described, shall take effect.

SECTION 4. COPIES TO BE DEPOSITED WITH CITY CLERK. Three (3) printed copies of Supplement No. 32 to the Tulsa Revised Ordinances shall be deposited with the City Clerk of the City of Tulsa.

SECTION 5. COPIES TO EACH HOLDER OF TULSA REVISED ORDINANCES. The City Clerk is authorized to transmit to each City employee who has been assigned a set of the Tulsa Revised Ordinances, and to each person and each library which have been presented a complimentary set of the Tulsa Revised Ordinances, copies of Supplement No. 32 to the Tulsa Revised Ordinances at no charge.
