Background Information

This ordinance will appropriate \$250,000.00 in total. \$200,000 will be recognized from the unappropriated fund balance to the Materials and Supplies, Other Services, and Capital accounts within the PD Equitable Sharing Justice Subfund (2400) inside the Tulsa Police Department. The appropriated funds will be utilized to for a rescue boat replacement, RTIC cameras, and for the Chief's discretionary training. The remaining \$50,000.00 will be recognized from the unappropriated fund balance to the Other Services accounts within the PD Equitable Sharing Treasury Subfund (2423) inside the Tulsa Police Department. The appropriated funds will be utilized for the Chief's discretionary training and travel.

AN ORDINANCE AMENDING THE FISCAL YEAR 2024-25 BUDGET OF THE CITY OF TULSA, OKLAHOMA TO MAKE SUPPLEMENTAL APPROPRIATIONS OF FIFTY THOUSAND DOLLARS AND ZERO CENTS (\$50,000.00), RECOGNIZED FROM UNAPPROPRIATED FUND BALANCE WITHIN THE PD EQUITABLE SHARING TREASURY SUBFUND (SUBFUND 2423) AND TWO HUNDRED THOUSAND DOLLARS AND ZERO CENTS (\$200,000.00), RECOGNIZED FROM UNAPPROPRIATED FUND BALANCE WITHIN THE PD EQUITABLE SHARING JUSTICE SUBFUND (SUBFUND 2400) AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the Fiscal Year 2024-25 Budget of the City of Tulsa, Oklahoma, is hereby amended to make supplemental appropriations of Fifty Thousand Dollars and Zero Cents (\$50,000.00), recognized from Unappropriated Fund Balance within the PD Equitable Sharing Treasury Subfund (Subfund 2423) and Two Hundred Thousand Dollars and Zero Cents (\$200,000.00), recognized from Unappropriated Fund Balance within the PD Equitable Sharing Justice Subfund (Subfund 2400) as follows:
