RESOLUTION NO.	

A RESOLUTION PROVIDING FOR THE CREDITING TO THE SINKING FUND OF THE CITY OF TULSA A CERTAIN PORTION OF THE INCOME AND EARNINGS OF THE SANITARY SEWERS AND SEWAGE DISPOSAL SYSTEMS EACH MONTH FROM THE SANITARY SEWER ENTERPRISE FUND IN ACCORDANCE WITH PROVISIONS OF ARTICLE V, SECTION 2.13, OF THE CHARTER OF THE CITY OF TULSA, OKLAHOMA; AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to the provisions of Article V, Section 2.13, of the Charter of the City of Tulsa, a sum equal to not less than fifty percent (50%) of the annual amounts required by law and necessary to pay the principal and interest on any sanitary sewers or sewage disposal bonds voted, issued, and sold on or after January 1, 1948, shall be apportioned and credited to the Sinking Fund of the City of Tulsa, such apportionments to be made monthly in a sum equal to not less than one-twelfth (1/12) of the amount required to be apportioned each year; and

WHEREAS fifty percent (50%) of the requirement for the fiscal year 2022-2023 for principal and interest on sanitary sewer bonds voted, issued and sold since January 1, 1948, is the sum of *Five Hundred Twenty Thousand and no*/100 *Dollars* (\$520,000.00).

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF TULSA:

Section 1. That it shall be and is hereby made the duty of the Finance Director of the City of Tulsa, to transfer to the Sinking Fund of the City of Tulsa, from the Sanitary Sewer Enterprise Fund of the City of Tulsa, the sum of *Forty-Three Thousand Three Hundred Thirty-Seven and no/100 Dollars* (\$43,337.00) for July 2022 and *Forty Three Thousand Three Hundred Thirty-Three and no/100 Dollars* (\$43,333.00) for August 2022 through June 2023.

Section 2. That an emergency is hereby declared to exist for the preservation of the public peace, health, and safety, by reason whereof this Resolution shall take effect immediately upon its adoption and approval.
