The Chris Brown Duathlon starts with a 5K run on paved streets within Mohawk Park, All streets are closed to public traffic. The course is a flat out-and-back. There is an aid station at the turn around and the course is easy to navigate. The third leg of the Chris Brown follows this same course.

In 2019 the run course was modified due to flood damage inside Mohawk Park. There are two turn-arounds before you return to the transition area. Pay attention to the course marshall's instructions.

- Follow Choctaw Dr and Chicksaw Dr to exit park Slow down for railroad tracks
- Turn Right (West) onto E 36th Street
- Turn Right (North) onto N Lewis Ave
- Turn Right (East) onto E 56th St N
- · Follow 56th St as it becomes Mohawk Blvd
- Turn Right (South) on N Mingo Rd/N 97th E Ave
- . Turn Right (West) on E 46th St N
- Turn Right back into Park Slow down for railroad tracks
- Take first Right back to transition Cherokee Dr
