We will start our day at the Super 11 Motel:

Two TPD Officers will be needed at 11th/Sheridan to control westbound traffic and one at 11th/S Norwood Ave to control eastbound traffic. A potential third officer would be needed at 12th/S Oxford Ave.

In the scene, fake prop guns will be brandished at a standoff at the motel, but we have an armorer and a special effects technician to make it look like a taillight gets shot out on the picture vehicle pulls away to end the scene. Basecamp will be at the old Skateland right by the motel.

Our second half of the day happens at Rentie Bros Salavge. We will be filming inside of the Salvage Yard. Three to Four TPD Officers will be needed at N Madison Ave/E 26th PI N, at E 27th St N/N Peoria Ave, at N Norfolk Ave/E 26th PL N, and potentially at N Norfolk Ave/E Apache Street. All officers would provide intermittent traffic control. The neighborhood is aware of our plans and all homeowners/business traffic can get through, as needed. Our Basecamp should be mostly set up at North Side Church on Norfolk.

We will need the exact same Fire Permit that we secured previously in September when we last filmed at Rentie Bros. The fireplace on site will be used in a scene.
