#### LOCATION ONE – May 24, 25, and 26:

We will film inside the old jail facility on Charles page for the first two days and inside and outside in the prison yard on the third day. **On 5/26, 4x TPD officers will be needed** to slow down the roads during our exterior shots and then to company move with us to the next filming location. We have 24/7 security at the facility currently and will have them there through wrap. **TPD Times: 11a-6p roughly on 5/26**

We will film the second half of our day at Rentie Bros Salvage. We will be filming inside of the Salvage Yard. Four TPD Officers will carry over from the previous set. They will be needed at N Madison Ave/E 26<sup>th</sup> Pl N, at E 27<sup>th</sup> St N/N Peoria Ave, at N Norfolk Ave/E 26<sup>th</sup> Pl N, and potentially at N Norfolk Ave/E Apache Street. All TPD Officers would provide intermittent traffic control. The neighborhood is aware of our plans and all homeowners/business traffic can get through, as needed.

Our Basecamp will set up at North Side Church on Norfolk.

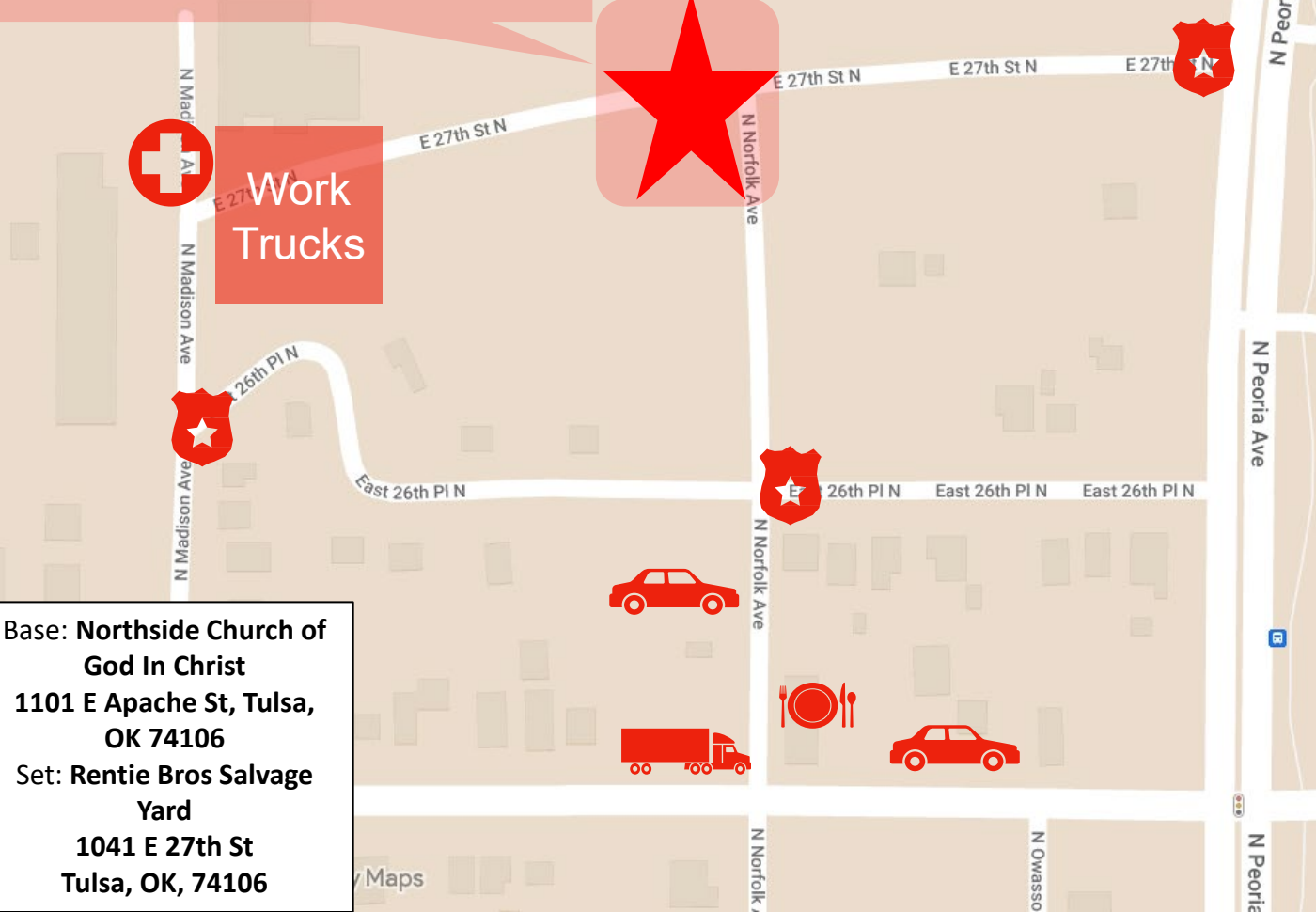

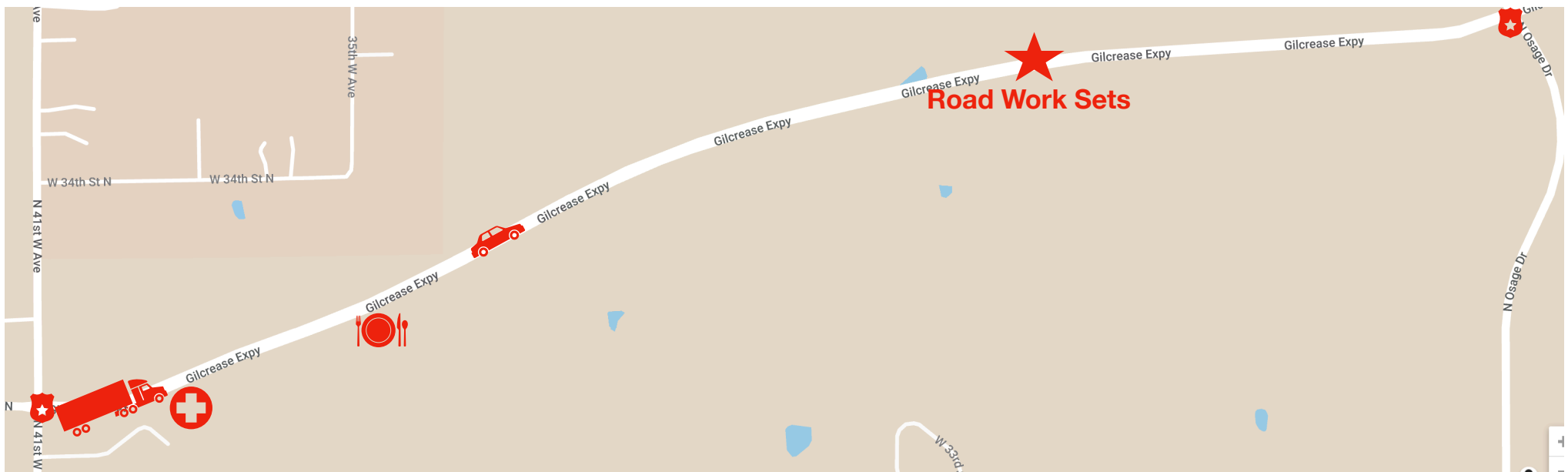
