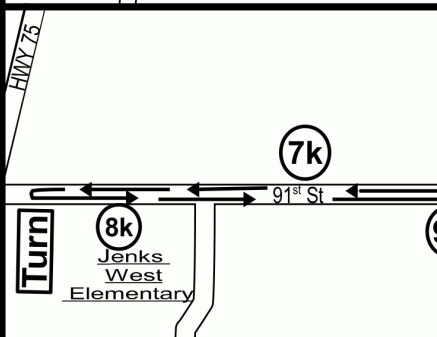

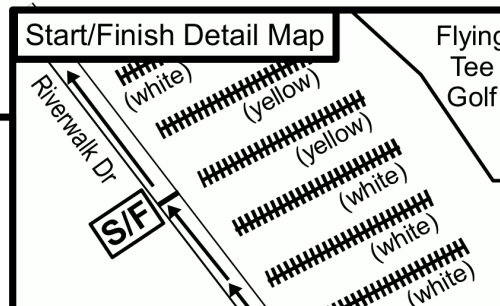
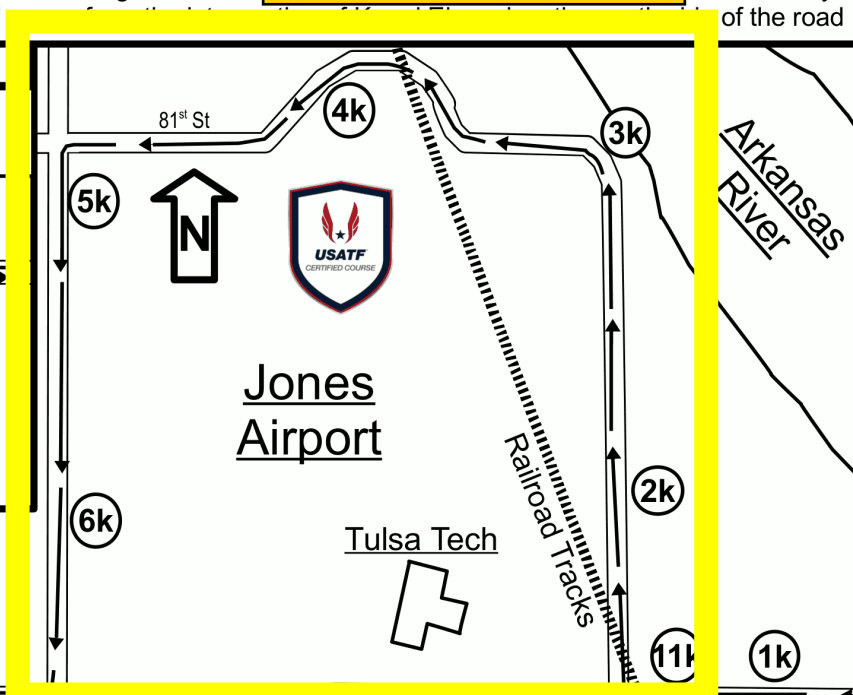
PORTION OF THE RACE IN

The 1st turn is 3.73 m west of the "35 MPH" & "End of School Zone" signs not far from the HWY 75 overpass



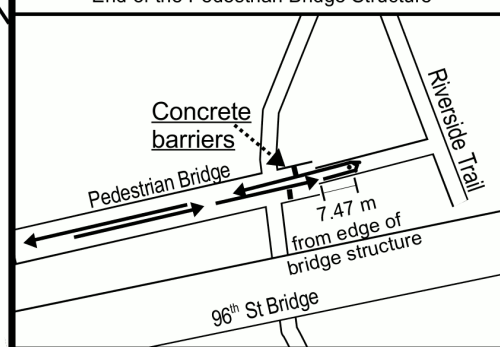
- 10k:** At the west edge of the intersection of 91st and Juniper St
- 11k:** On K place, at the center of the Birch & K Place Intersection
- 12k:** On B St, 3.4 m east of the the blue water pipe cover on the NE corner of Birch St & B St.
- 13k:** On B St, 8.8 m W of the speed limit sign just before the course turns S into parking lot
- 14k:** On the pedestrian bridge going back W, 12.5m E of 7th light pole from the W end of bridge



S/F is on Riverwalk Dr, next to Flying Tee Golf. There are two sets of parking spots that are yellow. S/F is in line w/ the expansion seam of the median in line w/ the southern most of the two sets of yellow parking spots
