The hold will happen at the intersection of W 47th St and S 27th W Ave - just north of the house/set.

On 5/31, 7:30am - 7:30pm: The 2x officers will mainly be a presence to keep the roads slow and safe.

On 6/1, 7:30am - 7:30pm: The 1x officer will again be a presence to make sure no one is a speed demon near our diner set.

On 6/2, 7:00am - 7:30pm: The officers will aid at multiple locations in the area. We'll start at the Conoco north of Umberto's and a picture vehicle will pull into the lot, so officer coverage will be used to make sure the roads are safe.

Then we'll need the full complement while we get a quick driving scene heading South out of the Conoco down Jamestown, East on E 32nd St, and then South on S Louisville.

After the driving scene, the officers will remain to keep the roads safe and slow while we film at other locations in the area.

Lastly on 6/5, 7:00am - 7:00pm: We make our glorious return to the closed jail facility on Charles Page, and the officers will be used to temporarily hold Charles Page while the camera gets a shot of a vehicle driving past the facility and then simply just being a presence while we film inside after that shot.
