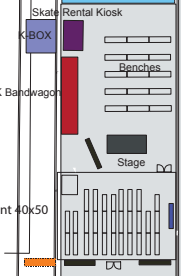

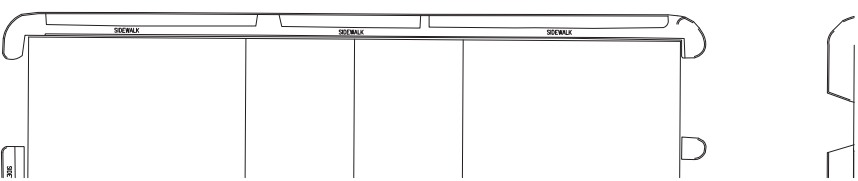
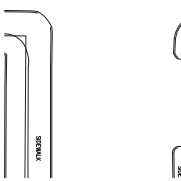


2023 - 2024 Site Map

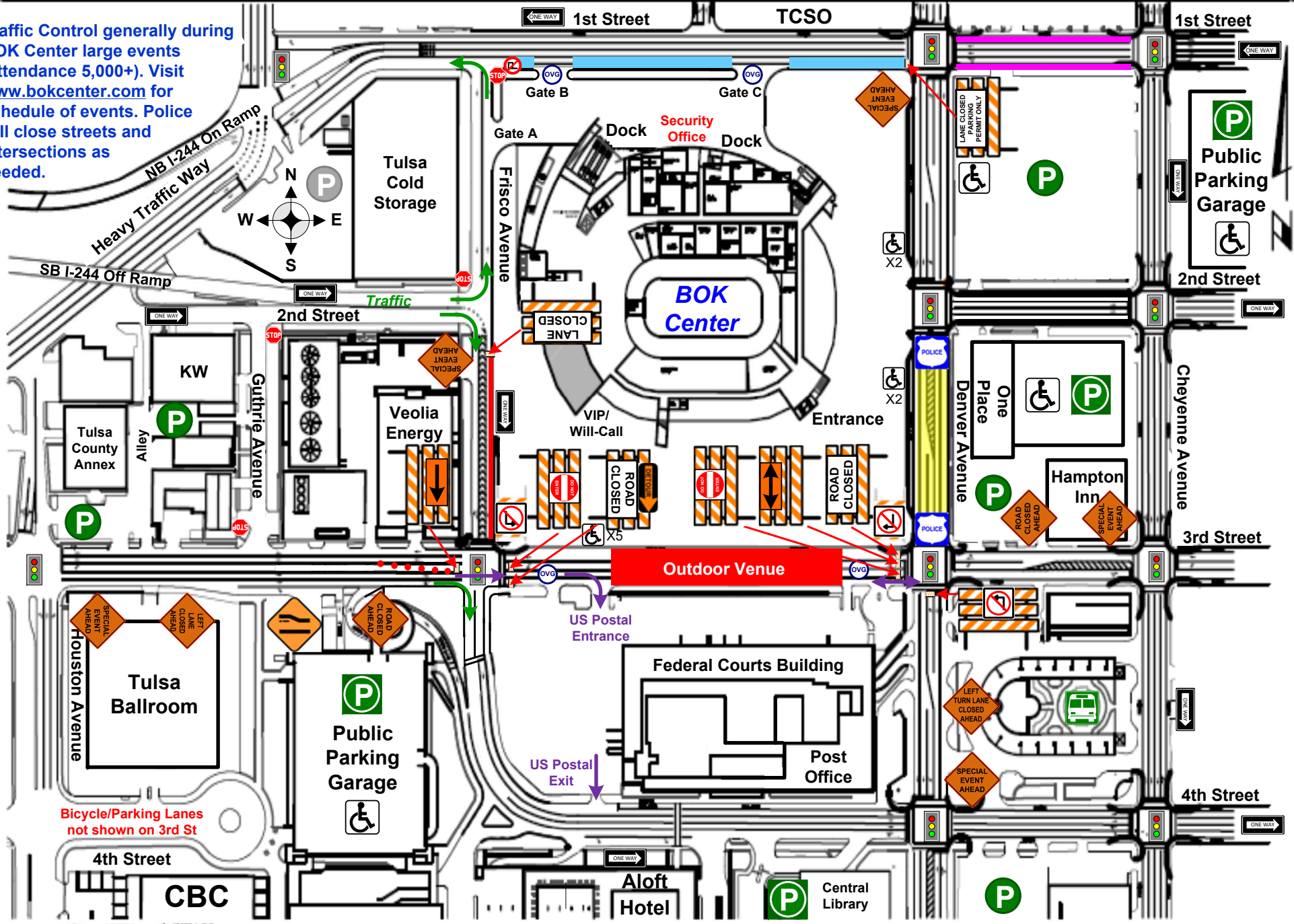



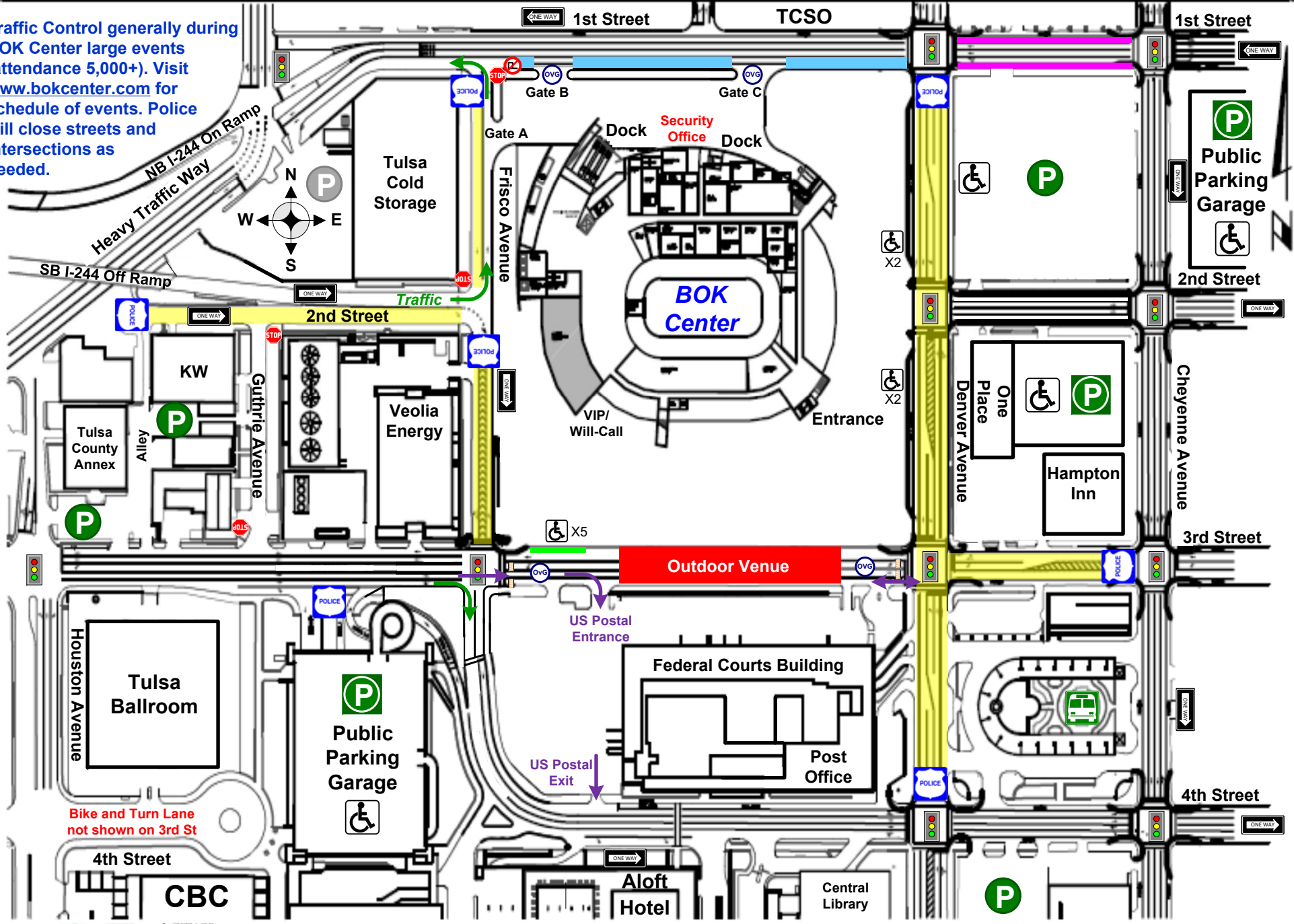
