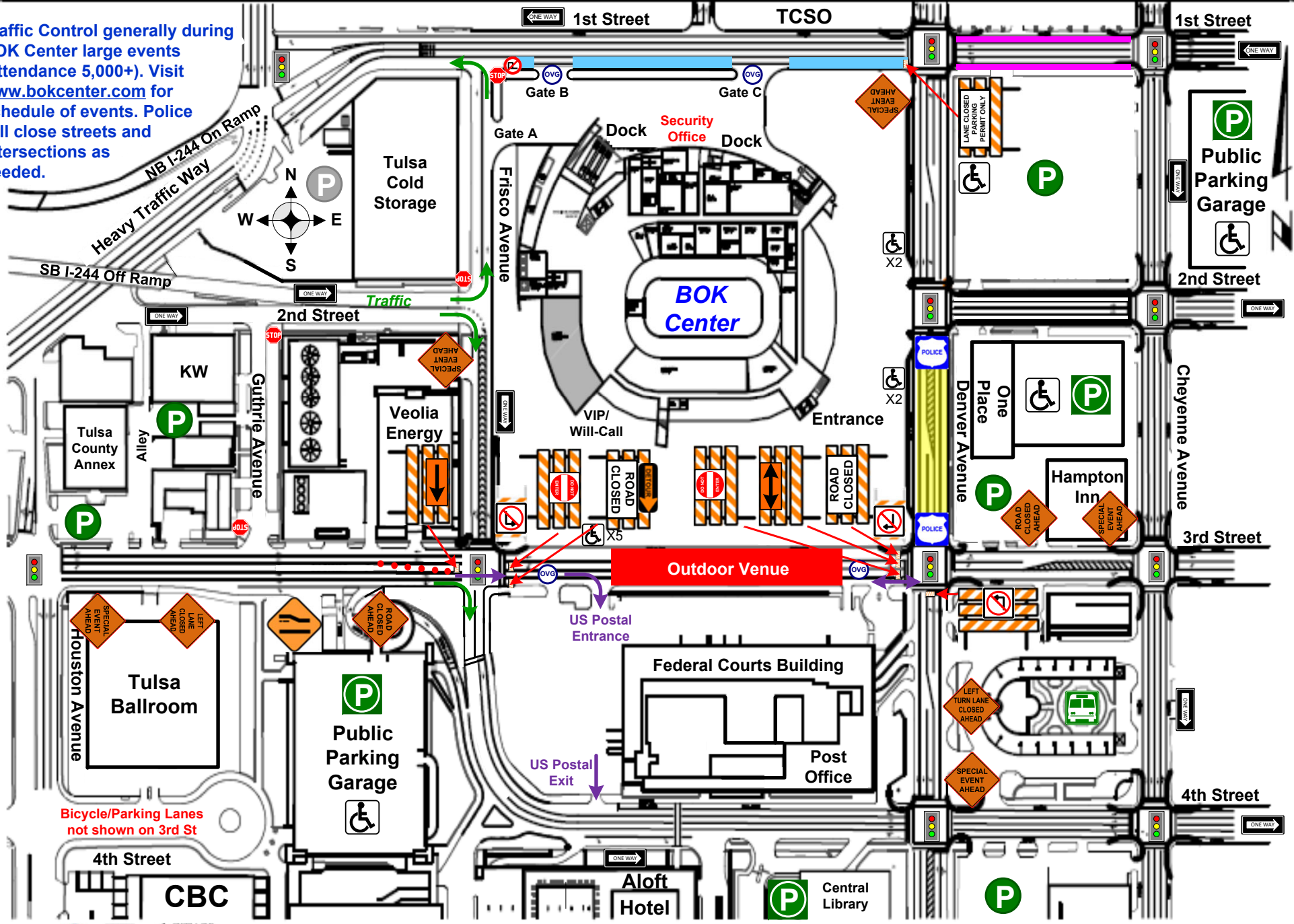

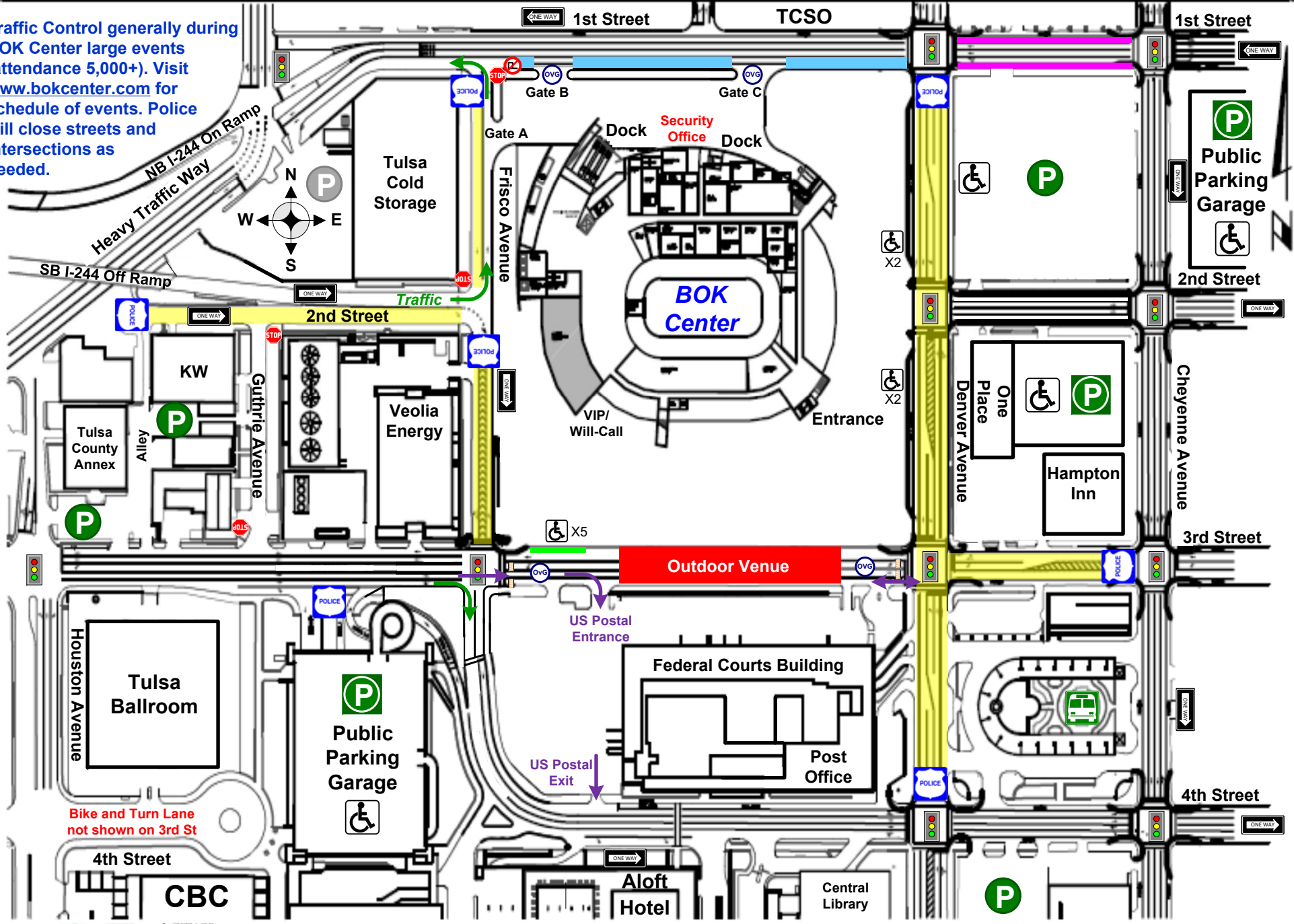
Bicycle/Parking Lanes not shown on 3rd St
