- Prepare presentations using photos and videos taken for internal and external communications
- Schedule interviews with Tulsa Police personnel for internal and external communications
- Maintain all equipment used for photography, videography, editing and, studio work
- Stay updated on the latest trends and technologies in photography and videography
- Reports to work on a regular and timely basis
