EXECUTIVE ORDER NO. 2016-5

ABOLISHING THE OFFICE OF CITY MANAGER; ABOLISHING THE DIVISION OF COMMUNITY DEVELOPMENT & TRANSPORTATION AND THE DIVISION OF ADMINISTRATION; ESTABLISHING THE DIVISIONS OF PLANNING AND DEVELOPMENT; RESILIENCE; PUBLIC WORKS; NEIGHBORHOODS, RECREATION & CULTURE; ADMINISTRATION; PUBLIC SAFETY SUPPORT; POLICE PROTECTION; AND FIRE SAFETY & EMERGENCY RESPONSE; RESCINDING ALL PREVIOUS EXECUTIVE ORDERS IN CONFLICT HEREWITH

WHEREAS, Article III, Section 1.6 of Tulsa's Revised Charter provides that the Mayor may, by executive order, create or abolish divisions for the management of the departments of the city; and

WHEREAS, the purpose of this organizational structure is to support the efficient and effective operation of City Government, and to reinforce the provision of reliable and responsive services to the Citizens of Tulsa.

NOW, THEREFORE, BY VIRTUE OF THE POWER VESTED IN ME AS THE MAYOR OF THE CITY OF TULSA, OKLAHOMA, IT IS HEREBY ORDERED:

SECTION 1. The Office of City Manager, the Division of Community Development & Transportation, and the Division of Administration, as previously configured, are hereby abolished.

SECTION 2. There is hereby created a **Division of Planning & Development**, which shall consist of the Departments of Planning, Development Services, and Economic Development, as well as such sections, agencies, and employees as may be necessary to accomplish the duties and functions assigned to said Division, including the City of Tulsa's relationship to and with INCOG and the Metropolitan Tulsa Transit Authority.

SECTION 3. There is hereby created a **Division of Resilience**, which shall consist of the City of Tulsa's Chief Resilience Officer, as well as such sections, agencies, and employees as may be necessary to accomplish the duties and functions assigned to said Division.

SECTION 4. There is hereby created a **Division of Public Works**, which shall consist of the Departments of Engineering Services, Streets & Stormwater, and Water & Sewer, as well as such sections, agencies, and employees as may be necessary to accomplish the duties and functions assigned to said Division.

SECTION 5. There is hereby created a **Division of Neighborhoods, Recreation & Culture**, which shall consist of the Departments of Working In Neighborhoods, Parks & Recreation, and the Performing Arts Center, as well as such sections, agencies, and employees as may be necessary to accomplish the duties and functions assigned to said Division, including the City of

Tulsa's relationship to and with the River Parks Authority, Gilcrease Museum, and the BOK Center and Cox Business Center.

SECTION 6. There is hereby created a **Division of Administration**, which shall consist of the Departments of Finance, Asset Management, Information Technology, Human Resources, Human Rights, Customer Care, and Communications, as well as such sections, agencies, and employees as may be necessary to accomplish the duties and functions assigned to said Division.

SECTION 7. There is hereby created a **Division of Public Safety Support**, which shall consist of the Departments of Municipal Court and Emergency Management, as well as such sections, agencies, and employees as may be necessary to accomplish the duties and functions assigned to said Division, including the City of Tulsa's relationship to and with the Emergency Medical Services Authority (EMSA).



SECTION 8. There is hereby created a **Division of Police Protection**, which shall consist of the Police Department, as well as such sections, agencies, and employees as may be necessary to accomplish the duties and functions assigned to said Division.

SECTION 8. There is hereby created a **Division of Fire Safety & Emergency Response**, which shall consist of the Fire Department, as well as such sections, agencies, and employees as may be necessary to accomplish the duties and functions assigned to said Division.

SECTION 9. This Executive Order supersedes all conflicting executive orders.

SECTION 10. This Executive Order shall take effect on the 5<sup>TH</sup> day of December, 2016.
