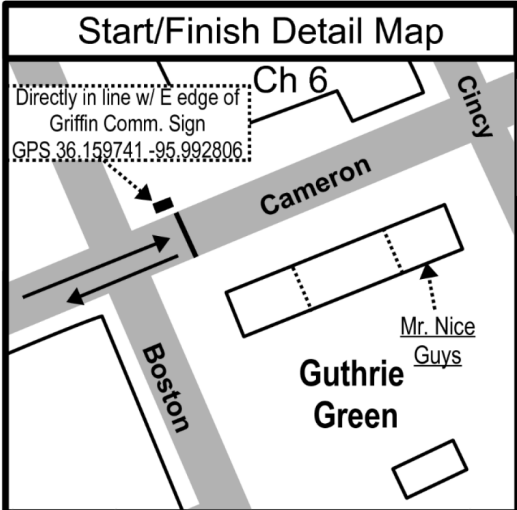

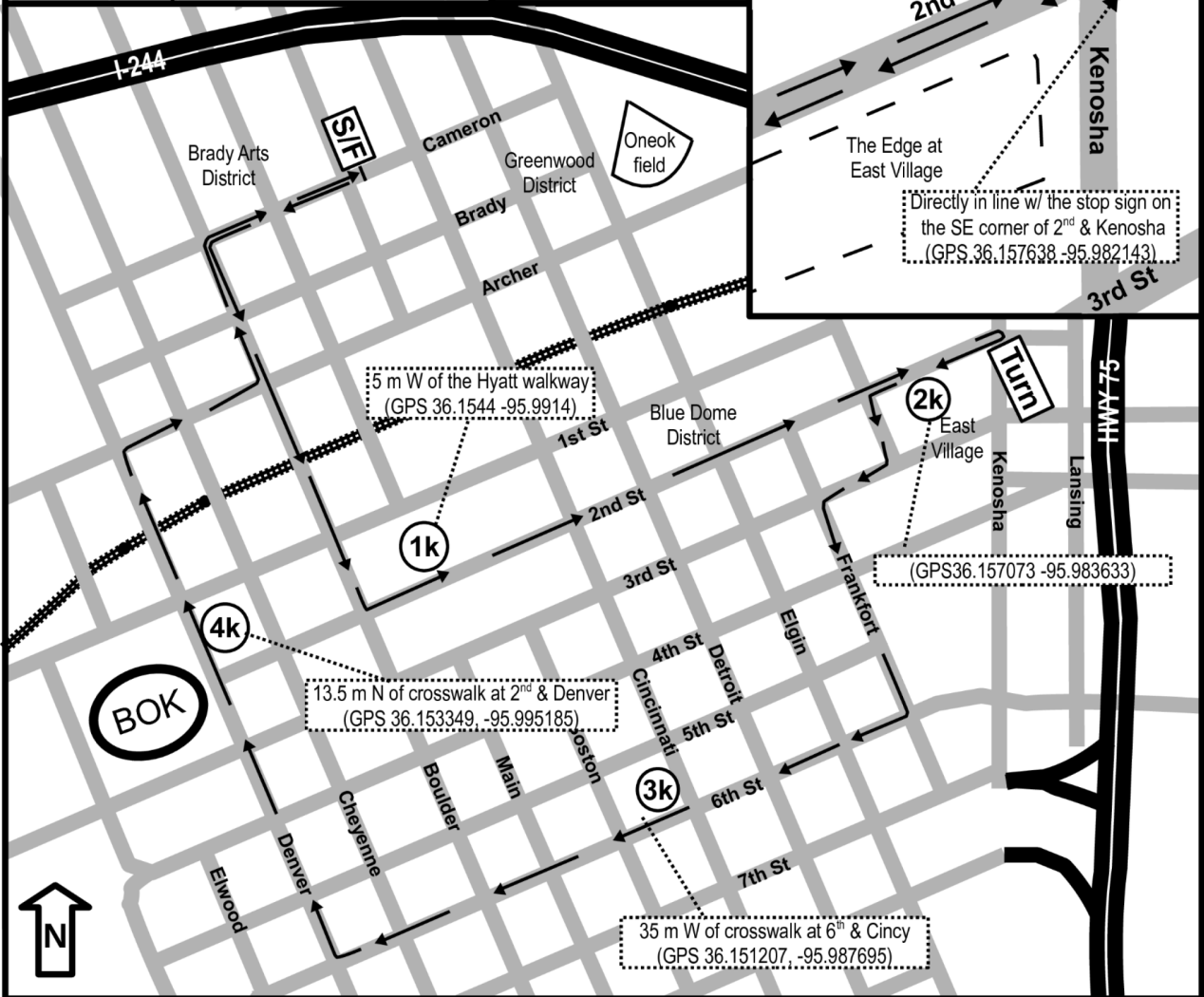
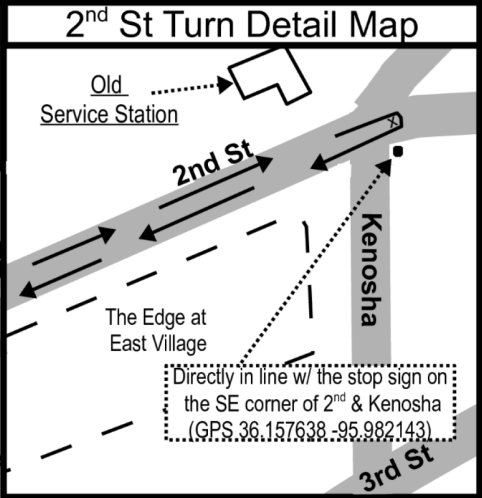
Guthrie Green 5k #5 - Tulsa, OK – 5,000 meters

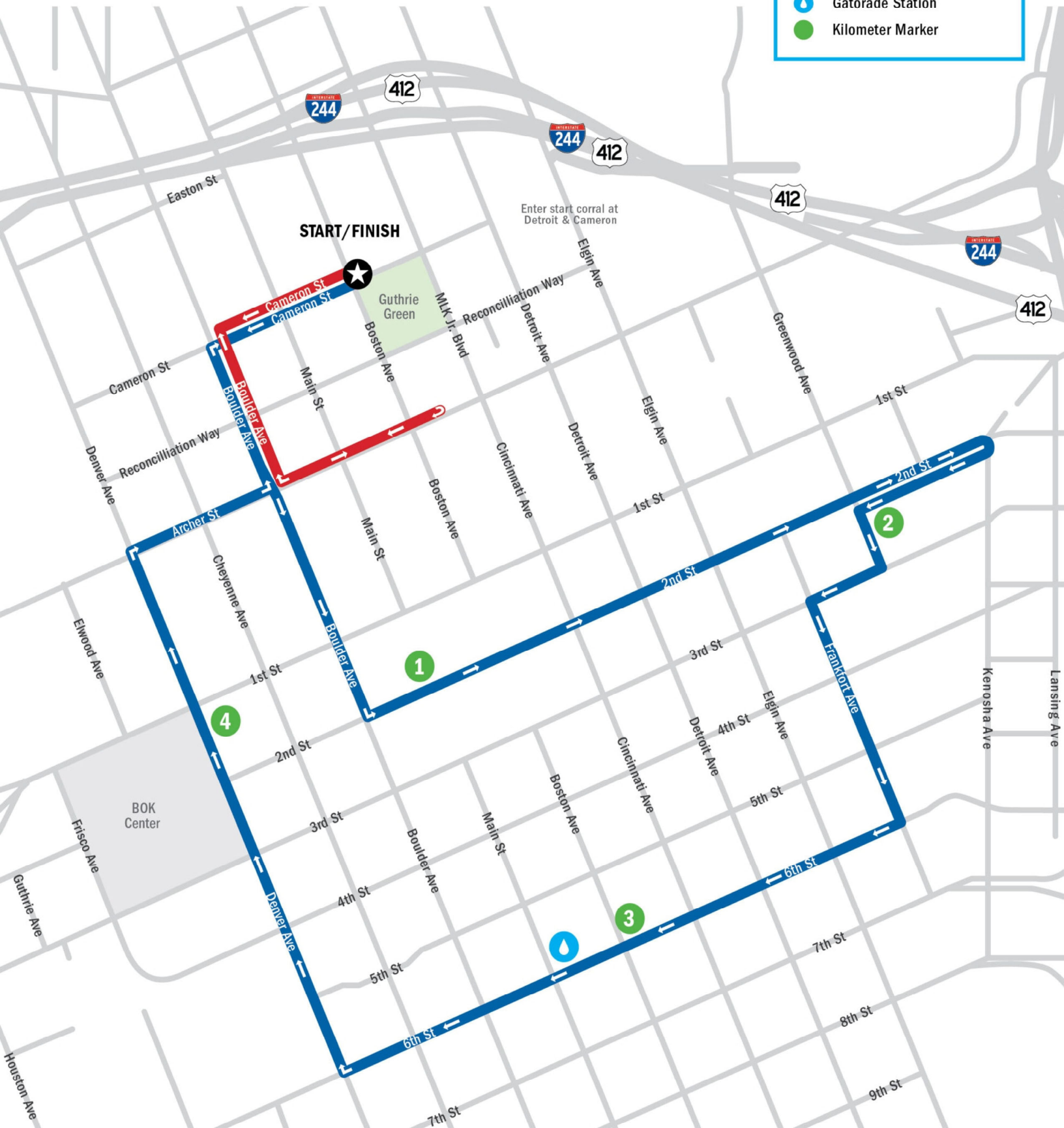


ROUTE 66 MARATHON

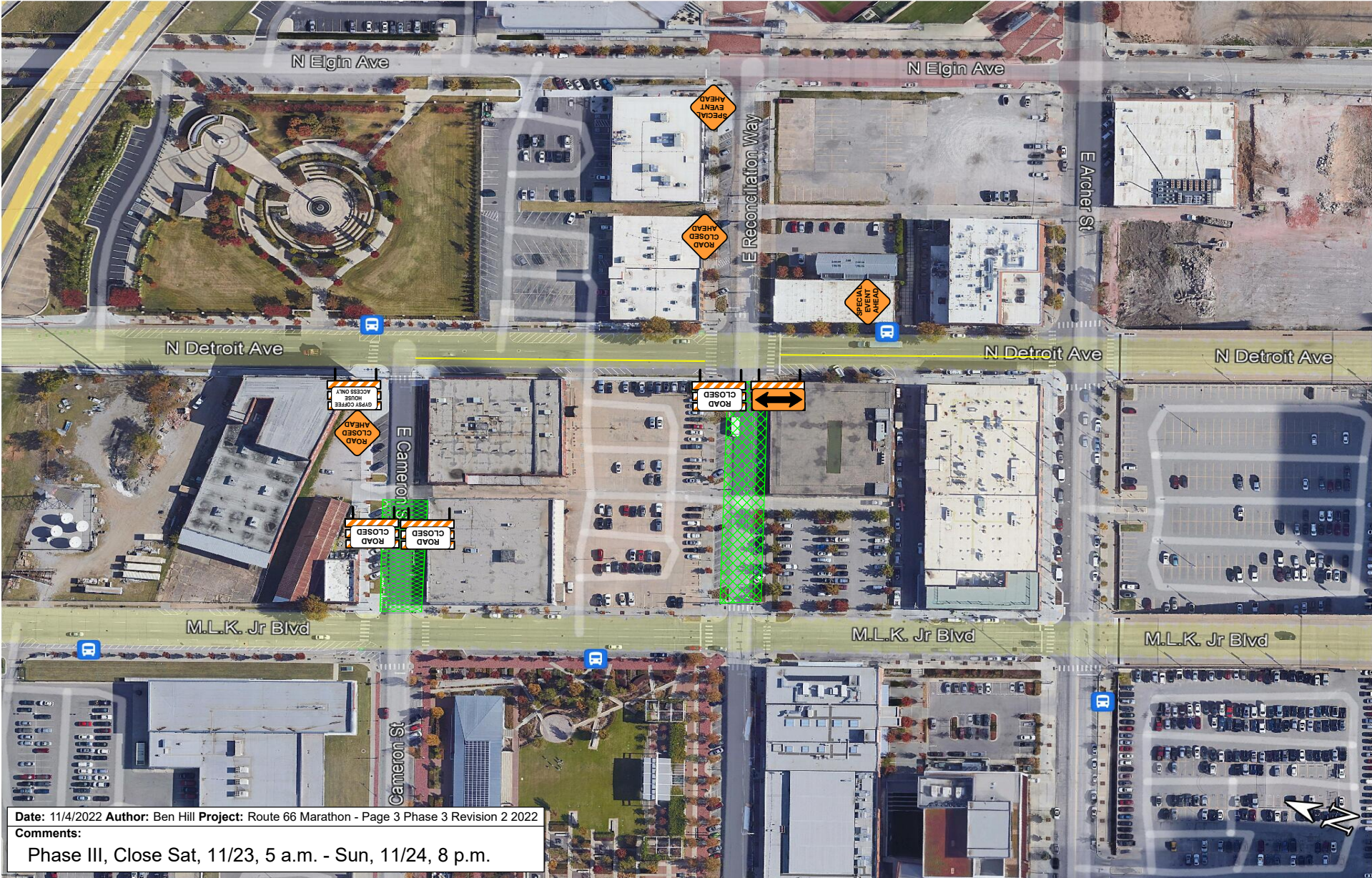
