Additional Fees Added to the Special Event and Film Permit Applications.

As of January 2026, the Tulsa City Council has approved the following. The Film application fees have increased. No changes to the Special Event application fees.

The substantially complete application shall be received by the Special Events Coordinator not less than the following number of days prior to the commencement of the event or film.

- Sixty (60) days for Major Events involving the temporary use of public rights-of-way or a
 combination of private property and public rights of way. Events that are less than thirty (30)
 days out and do not have an application already submitted must receive approval to submit
 a late application from the Special Events Coordinator.
 - a. An application submitted less than sixty (60) days prior to the commencement of the event shall be assessed with an additional fee of Two Hundred Dollars (\$200).
 - b. An extended Major Event shall mean a major event that is continuous in duration for longer than one (1) month. For an extended major event, there shall be an additional fee assessed in the amount of One Hundred Fifty Dollars (\$150.00).
- 2. Forty (40) days for Minor Events involving the temporary use of only private property. Events that are less than twenty (20) days out and do not have an application already submitted must receive approval to submit a late application from the Special Events Coordinator.
 - a. An application submitted less than Forty (40) days prior to the commencement of the event shall be assessed with an additional fee of One Hundred Dollars (\$100).
- 3. Thirty (30) days for Monthly Events involving the temporary use of public or private property, which may include multiple dates but same location within a calendar month. Events that are less than fifteen (15) days out and do not have an application already submitted must receive approval to submit a late application from the Special Events Coordinator.
 - a. An application submitted less than Thirty (30) days prior to the commencement of the event shall be assessed with an additional fee of One Hundred Dollars (\$100).
- 4. Ten (10) days for Film Productions for any outdoor film-making which will block pedestrian and/or vehicular traffic, incorporate Intermittent Traffic Control (ITC), use of a Drone, or to take place on public or private property, which may include multiple dates and locations, shall pay a non-refundable application fee as set forth in this section when an application is submitted ten (10) days or more prior to the commencement of the film. Films that are less than five (5) days out and do not have an application already submitted must receive approval to submit a late application from the Special Events Coordinator.
 - a. The non-refundable application fee assessed shall be set forth in this section when an application is submitted ten (10) days or more prior to the commencement of the film.

- 1. Film on private property....\$150.00
- 2. Film on public rights-of-way\$450.00
- b. Applications submitted less than ten (10) days prior to the commencement of the film shall be assessed with an additional fee of One Hundred Dollars (\$100).

Special events requiring additional services, as requested by the Organizer and/or as determined by the Special Events Coordinator or other City official, shall require service fees. Fees for additional services shall be calculated by the appropriate City department and invoiced to the special event organizers after the special event occurs. A schedule of such approved fees for such services follows:
