PURPOSE OF THE CLASSIFICATION: Under general direction is responsible for developing and implementing the North Tulsa Wellness Initiative (NTWI), a Tobacco Settlement Endowment Trust (TSET) grant program, for the purpose of improving the health and quality of life for people in the Whitman and Hawthorne neighborhoods of Tulsa; responsible for developing contracts for services and coordinating regular meetings with partners and stakeholders; and performs other related duties as assigned.

ESSENTIAL TASKS:

- Develops and manages the North Tulsa Wellness Initiative TSET grant program by creating implementation plans, tracking systems, evaluation frameworks for actions and projects ensuring successful project completion
- Coordinates with the Tobacco Settlement Endowment Trust (TSET) on all grant requirements and deadlines
- Ensure compliance with grant evaluation requirements
- Develops and monitors all contracts for services and programs required under the grant program, including community-based organizations providing services and any project personnel
- Develops and tracks key performance indicators in partnership with a third-party evaluator
- Coordinates the grant's advisory board and engages formal and informal partners to effectively implement the initiative
- Provides regular status reports to City leadership, funders, residents, and community stakeholders on the progress of initiatives
- Establishes collaborative team-oriented relationships with people at all levels of the organization
- Reports to work on a regular and timely basis
