**PURPOSE OF THE CLASSIFICATION:** Under general direction is responsible for technical and administrative work involving all areas of environmental protection and regulatory compliance with primary emphasis on drinking water, wastewater or storm water system sampling, flow, concentration and pollutant loading calculations, pretreatment system design reviews, inspections and improper discharge or drinking water investigatory activities and performs other related assigned duties.

#### **ESSENTIAL TASKS:**

- Reviews and coordinates the work of subordinate personnel in drinking water system, industrial pretreatment or storm sewer discharge programs and other environmental or public health areas
- May inspect and permit new or existing sources of industrial waste discharges
- Assists industry's effort in pollution prevention and water conservation through the distribution of publications, training and site assessments
- Assists in the dissemination and presentation of public health or environmental awareness information
- Investigates reports of drinking water complaints in distribution system, illegal or problem waste entering the sanitary or storm sewer systems and initiates appropriate remedial procedures
- Inspects and/or reviews pretreatment system plans of proposed industrial or commercial wastewater sources
- Assists in administration of drinking water compliance monitoring, pretreatment, storm water, hazardous materials, pollution prevention or other programs
- Directs and trains personnel and assists in ensuring compliance with applicable federal, state and local drinking water and sanitary pretreatment standards and discharge limitations or storm water regulations and permits
- Assists data computerization needed for report generation and distribution to industries, citizens and regulatory agencies
- Revises and interprets pertinent federal, state and local regulations
- Performs/oversees sampling of drinking water, sanitary sewer or storm water systems with specialized sampling equipment
- May respond to hazardous chemical releases to the sanitary and/or storm water systems and supervises clean-up of releases or spills
- Performs environmental assessments of property
- Compiles, analyzes and interprets data
- Prepares and presents reports, purchase requisitions and budget requests
- Maintains various records and inventory

- (b) Two (2) years' experience related to water and wastewater treatment, industrial waste disposal or storm water management

- Receives a "Proficient" rating on the most current performance evaluation

- Demonstrate knowledge of MS4 Permit OKS000201 through a minimum score of 80% on the MS4 Permit knowledge test
- Completion of Defensive Driving or Customer Service Training, not previously submitted, as approved by management

- Oklahoma Conservation Commission Fish School training or Floodplain Managers 101 Training as approved by management, and,

- Eighteen (18) months experience as an Environmental Compliance Coordinator, and
- Receives a "Proficient" rating on the most current performance evaluation

### Public Works 3<sup>rd</sup> Proficiency:

- Demonstrate knowledge of Title 11-A, Chapter 5 (Pollution) Ordinance with the minimum test score of 80% on the Pollution Ordinance knowledge test and,
