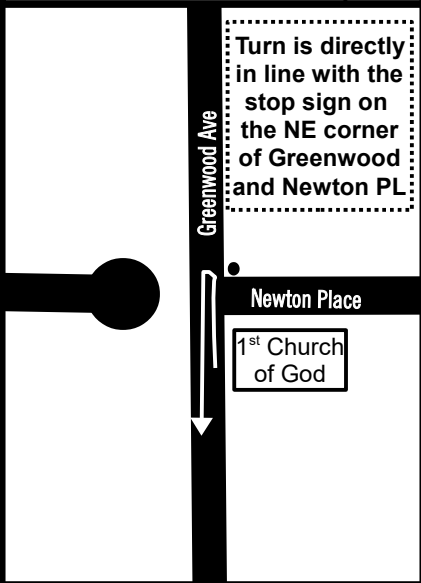

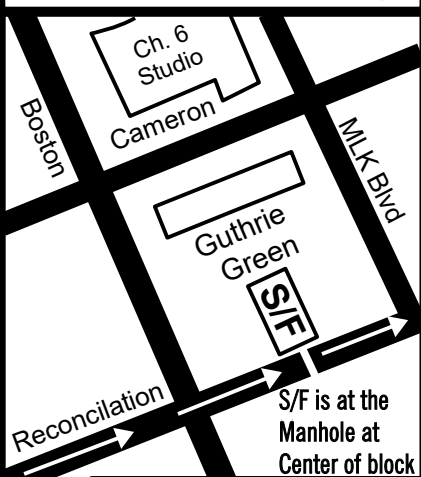

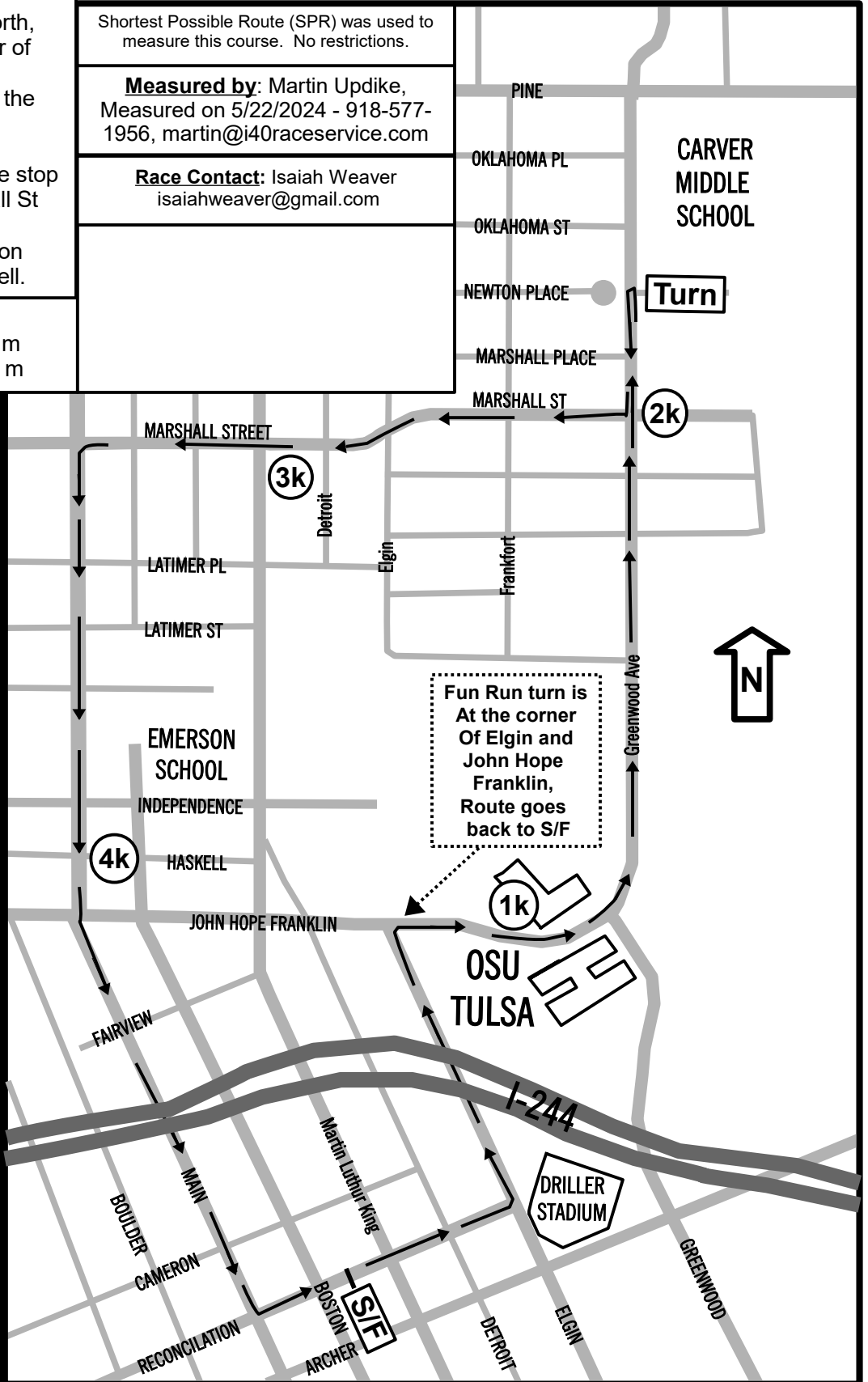
Turn Detail Map
